Article IX. Delegates to the Association's House of Delegates

- Section 2. Election and Term
 - A. The Chief Delegate shall be elected as outlined in Article V. Section 5.
 - B. Prior to the annual session of the Association's House of Delegates, the Chapter shall elect the number of Delegates to which the Chapter is entitled. The Chapter may also elect Alternate Delegates. The Delegates shall be elected by plurality vote.
 - 1. In the event of mandatory reduction of Delegates, the lowest vote recipient will become an Alternate Delegate.
 - 2. Only one (1) Physical Therapist Assistant Member can be a member of the delegation.
 - C. All Delegates, except the Chief Delegate, shall serve a term of two (2) years and two (2) consecutive House of Delegates. Their terms shall begin after their predecessor serves two (2) consecutive House of Delegates.
 - D. No Delegate (including the Chief Delegate) shall serve more than two (2) consecutive elected terms.
 - E. The President shall automatically serve as an Alternate Delegate.
