Secretary

- 1. What experiences and qualities make you a strong candidate for the Secretary position?
 - I currently serve as the Chapter Secretary. During my term, I have maintained an accurate log of chapter activities, which is often used for reflection when questions/concerns arise. In this role, I also serve as the liaison for the membership committee. I have worked alongside the membership chair to identify ways to increase membership within the state. Together, we identified that a majority of students do not maintain their membership post-graduation. As a result, I have worked with PTs and PTAs to establish an Early Professionals Special Interest Group. This group affords our clinicians an opportunity to serve at the start of their careers. It also allows support for our Early Professionals (mentoring, career consultation, etc).
- 2. The Chapter is a member-driven organization. How do you feel the communication is between the membership and the Board and vice versa? How could it be improved (if necessary)?
 - I believe the communication between the membership and Board has improved, but it could continue to improve. To help, I would schedule monthly meetings with the Membership Chair. In doing so, we would focus on the retention of our PT and PTA students as they transition into Early Professionals. After review of the 2018 year, our retention was low, at 46.58%. As a result, we would devote greater time to scheduled meetings with the Student and Early Professional Special Interest groups, to inquire of their needs. All of the information would be given to the Board to improve their knowledge of chapter activities and to better support our committees.
