Online surveys are an effective way to gather anonymous input. Social media provides other avenues for members to share views and issues. An information page on the website could provide timely information about the HOD. Blogs and chat rooms would allow conversations to develop around relevant topics.

Delegates should be approachable; either through email, video conferencing or at other events such as pub nights. A virtual town hall could be held once or twice a year to allow members to engage with the delegation. The delegation needs to hear the important issues facing the profession, in order to make the best decisions possible.

The delegation can continue to inform the chapter on the activities of the HOD at the Alabama Annual Conference, but the delegates should be more visible, so that when issues or questions arise, members and non-members, know who to contact. Together we can move the profession forward and provide the best care possible to our patients.
